

# PUBLIC NOTICE CALLING FOR THE INSPECTION OF THE 3rd SUPPLEMENTARY VALUATION ROLL FOR THE YEAR 2019-2024 AND LODGING OF OBJECTIONS

Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(2) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), herein referred to as the "Act", that the 3<sup>rd</sup> Supplementary Valuation Roll for the financial year 2019-2024 is open for public inspection at our website <a href="http://www.ulundi.gov.za">http://www.ulundi.gov.za</a> and Council offices (Finance Department Office) from 02 May 2022 to 03 June 2022.

In terms of Section 50 of the said Act, any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the Property Valuation Roll must do so in the prescribed forms.
