

PROVINCIAL NOTICE 230 OF 2022



NOTICE OF CHANGES TO THE PROCEDURES, TIMETABLES AND REQUIREMENTS IN MATTERS COVERED IN THE INVITATION: DETERMINATION OF BOOKMAKING RIGHTS & INVITATION TO TENDER

- 1. Pursuant to the submission of bids in response to an invitation to tender for Bookmaking Rights which was advertised in the Provincial Government gazette No. KZN 2268-08-04 on 08 April 2021, the KwaZulu-Natal Gaming and Betting Board hereby gives notice, in terms of clause 12.2.1 of the invitation, to all persons who submitted bids in response to the invitation of changes to the procedures, timetables and requirements covered in the invitation.
- 2. According to clause 8 of the invitation, the process initiated by the Board entails two (2) separate and distinct phases. The first phase entails an open competitive tender process where the highest qualifying bidders will win the right to enter the second phase. The second phase entails a formal application for a bookmaker's licence by the winning bidders.
- The changes that are being implemented relate to the first phase and entail the following:
- 3.1 The removal and discarding of duplicate bids from the register of bids that will be evaluated. The duplicates were a result of both manual and electronic submission by one bidder and/or bidding for different areas in one district municipality.
- 3.2 The removal and discarding of bids that were rejected in terms of clause 10.3 of the invitation for failure to submit the mandatory information/documentation from the register of bids to be evaluated.
- 3.3 The removal and discarding of bids that were evaluated and scored below one hundred and twenty (120) points, and
- 3.4 Extending an invitation to the bidders that were evaluated and scored one hundred and twenty points (120) to do formal oral presentations to the Licensing Committee for purposes of obtaining full information about each highest tenderer so that the decision on the bid/bidder whose bid best achieves the objects of the Act is fair, well considered and objective.

- 3.5 The oral presentations to be evaluated in terms of the evaluation criteria and the objects of licensing as stipulated in clauses 9 and 5 respectively of the invitation to tender, including but not limited to :-
- 3.5.1 Creation of opportunities for Black persons
- 3.5.2 Transformation through new entrants
- 3.5.3 Promotion of BEE with focus on women, youth and people with disabilities
- 3.5.4 Employment opportunities in townships and less developed areas of the Province
- 3.5.5 Contribution towards increase in knowledge and skills relevant to the Betting industry
- 3.5.6 Locality of the proposed business premises
- 3.5.7 New form of entertainment in the area of choice
- 3.5.8 Contribution to CSI/CSD in the area of choice
- 3.5.9 Additiona revenue for the fiscus from operations (projections)
