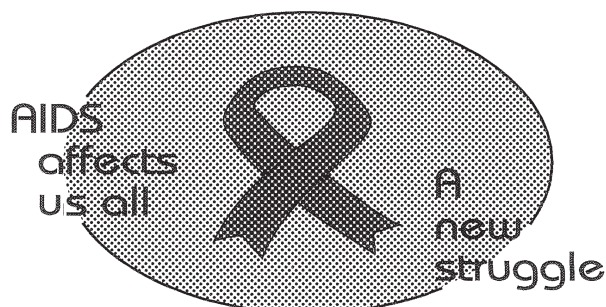

**PUBLIC NOTICE CALLING FOR INSPECTION OF SUPPLEMENTARY VALUATION ROLL  
AND LODGING OF OBJECTIONS FOR UMZUMBE MUNICIPALITY**

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government Municipal Property Rates Act, of 2004 (Act No.6 of 2004) as amended, herein referred to as the "Act", that the supplementary valuation roll for the financial period 1 July 2022 to 30 June 2023, is open for public inspection.

An invitation is hereby made in terms of Section 49(1)(a)(ii) of the Act that any owner of property or other person who desires should lodge an objection with the Municipal Manager in respect of any matter reflected in , or omitted from, the supplementary valuation roll within the below mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act, an objection must be in relation to a specific property and not against the valuation roll as such.

Inspections can be done during office hours as follows: Monday to Thursday between 08H00 – 16H30 and on Friday between 07H30 to 16H00.

The valuation roll is available for inspection for a period of 30 days from 05 May 2023 to 03 June 2023 at the Umzumbe municipal office, Mathulini MPCC, Sipofu.
