

EXEMPTIONS, REDUCTIONS AND REBATES

Residential Properties: For all residential properties, the municipality will not levy a rate

on the first R35 000 of the property's market value. The R35 000 is inclusive of the R15

000 statutory impermissible rate as per section 17(1)(h) of the Municipal Property Rates

Act.

Rebates in respect of a category of owners of property are as follows:

Indigent owners: 100% Rebate

Child headed households: 100% Rebate.

Owners who are dependent on Pension or Social Grants for their livelihood: 50%

Rebate

each category of owners of properties or owners of a specific category of properties as

determined through criteria in the municipality's rates policy are available for inspection

on the municipality's offices, website (www.nongomamunicipality.gov.za) and public
