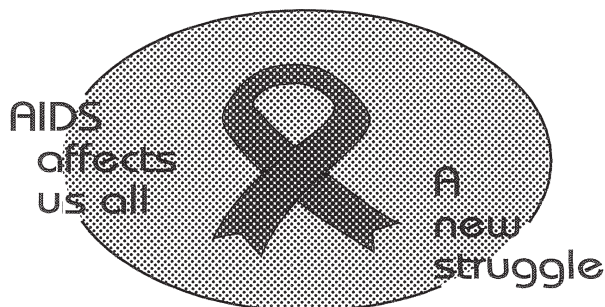

I, Bongiwe Nomusa Sithole-Moloi, Member of the KwaZulu-Natal Executive Council responsible for Cooperative Governance and Traditional Affairs hereby give notice under powers vested in me by Section 23(3)(b) of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998) in respect of the redetermined technical and minor outer municipal boundaries. In terms of Section 23(2)(b) of the Local Government: Municipal Demarcation Act, the Independent Electoral Commission published in the Provincial Gazette No. 2525/62 on 31 March 2023 that the redeterminations will not affect the representation of voters in the council of the municipalities concerned, namely uMngeni, iMpendle, Mpofana, Mkhambathini, Richmond, Dr Nkosazana Dlamini-Zuma, iNkosi Langalibalele, Ray Nkonyeni, eThekweni, KwaDukuza, uMzumbe, and Okhahlamba. Thus, the redetermined technical and minor outer municipal boundary changes will take effect on 01 July 2024.
