EXEMPTIONS, REDUCTIONS AND REBATES

“In terms of section 15 of the Local Government: Municipal Property Rates Act, 2004”

Residential Properties: For all residential properties, the municipality will not levy a rate on the first R60 000 of the property’s market value. The R60 000 is inclusive of the R15 000 statutory impermissible rate as per section 17(1)(h) of the Municipal Property Rates Act.

Rates relief in respect of a category of owners of property are as follows:

Indigent owners: 100% Rebates

Full details of the Council resolution and rebates, reductions and exemptions specific to each category of owners of properties or owners of a specific category of properties as determined through criteria in the municipality’s rates policy are available for inspection on the municipality’s offices, website (www.ulundi.gov.za) and public libraries within the municipality’s jurisdiction.
