CALL FOR PUBLIC COMMENTS: DRAFT KZN PUBLIC INTEREST ASSESSMENT POLICY IN RELATION TO LIQUOR LICENCE APPLICATIONS WITHIN KZN

In terms of Section 48 (5) and (6) of the KwaZulu- Natal Liquor Licensing Act 2010 (Act 6 of 2010) as amended, *the KwaZulu-Natal Liquor Authority must satisfy itself before granting an application that the granting of the application will be in the public interest.*

In determining whether the application will be in the public interest, a legal framework must serve as a guide for both the potential liquor licence applicant and members of society to know in advance what is expected of them and factors that will be considered by the KZNLA when considering such an application.

The draft KwaZulu-Natal Public Interest Assessment Policy therefore provides a policy framework for the consideration of issues of public interest when considering applications for a liquor licence within residential areas as provided for in section 48 of the KZN Liquor Act of 2010.

The Member of the Executive Council (MEC) for Economic Development, Tourism and Environmental Affairs invites all members of the public and relevant stakeholders to attend public consultations on the draft KwaZulu-Natal Public Interest Assessment Policy. The purpose of public consultations is to provide an opportunity to all persons within the Province of KZN to make written or verbal comments on the draft Policy.
