

## PROVINCIAL NOTICE PROVINSIALE KENNISGEWING

ACT

To authorise certain unauthorised expenditure in the Limpopo Department of Education; to charge the Provincial Revenue Fund accordingly and to provide for matters connected therewith.

**BE IT ENACTED** by the Limpopo Provincial Legislature as follows:—

- 1. Authorisation of unauthorised expenditure 2006/2007 financial year**
  - (1) The Provincial Revenue Fund is charged with the amount of R148, 958, 000.00 (one hundred and forty eight million nine hundred and fifty eight thousand rand) to authorise certain unauthorised expenditure for the 2006/2007 financial year as set out in the Schedule.
  - (2) The Limpopo Provincial Legislature authorised unauthorised expenditure in the amount of R148, 958, 000.00 as set out in the Schedule for the 2006/2007 financial year which ended on 31 March 2007.
  - (3) The expenditure referred to in subsection (1) is fully described in the 2006/2007 Report of the Auditor-General and is a direct charge against the Provincial Revenue Fund.

- 2. Action of recovery of unauthorised expenditure**

Nothing in this Act may in any way be construed as affecting any action to recover unauthorised expenditure.

- 3. Short title**

This Act is the Limpopo Second Unauthorised Expenditure Act, 2010.


