

# PUBLIC NOTICE CALLING FOR INSPECTION OF THE SUPPLEMENTARY VALUATION ROLL AND LODGING OF OBJECTIONS

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that the first Supplementary Valuation Roll for financial years 2014 to 2018 will be open for public inspection at the Municipal Offices, c/o Landros Mare & Bodenstein Streets, Polokwane, as well as the Municipality's website <a href="www.polokwane.gov.za">www.polokwane.gov.za</a> from 1 July 2014 to 1 August 2014.

An invitation is hereby made in terms of section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires, should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the Supplementary Valuation Roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the Supplementary Valuation Roll as such.

The prescribed forms regarding lodging of an objection is obtainable at the following municipal offices: Civic Centre, Rates Hall (Polokwane), Seshego, Mankweng, and Sebayeng or on the website <a href="https://www.polokwane.gov.za">www.polokwane.gov.za</a>
