

PUBLIC NOTICE CALLING FOR INSPECTION OF THE FINAL SUPPLEMENTARY VALUTION ROLL AND LODGING OF OBJECTIONS FOR THE PERIOD ENDED 30 JUNE 2014

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that the final Supplementary Valuation Roll for the financial year ended 30 June 2014 will be open for public inspection at the municipal offices of Polokwane Municipality, c/o Landros Maree & Bodenstein Streets, Polokwane from 29 September 2014 to 31 October 2014. In addition final Supplementary Valuation Roll will be available on the Municipality's website, <u>www.polokwane.gov.za</u>.

An invitation is hereby made on terms of section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires, should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from the final Supplementary Valuation Roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the final Supplementary Valuation Roll as such.
