The Electoral Commission has in terms of section 23 (3) of the Local Government: Municipal Demarcation Act, 1998 (Act No 27 of 1998) recorded its view that the boundary redetermination as determined by the Municipal Demarcation Board in terms of section 21(5) (c) of the Local Government: Municipal Demarcation Act, of municipalities referred to in schedule 1 as reflected in Notice 119 published in the Government Gazette No 2932 dated 10 Augustus 2018 will not materially affect the representation of voters in the councilors of these municipalities.
