- 2) That this rule be published in the local and provincial print media and the Provincial Gazette.
- 3) That the following bank accounts be frozen:

 - c) Standard Bank: Account No.330575767, Branch Code 052749, opened under the name of the **South African Credit Blacklisted Rescue held at Tzaneen.**
- 4) That the respective Department of Education and that of Health in the province of Mpumalanga immediately stop deducting money nor be paid to the respondent.
- 5) That the respondents be ordered to pay the cost of this application.
