

MUNICIPAL PROPERTY RATES (VALUATION ROLL) PUBLIC NOTICE CALLING FOR INSPECTION OF VALUATION ROLL

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No 6 of 2004), hereinafter referred to as the "Act", that the valuation roll for the Financial Year 1 July 2013 to 30 June 2017 is open for public inspection from 04 February 2013 – 31 March 2013 at the Municipal Offices during office hours (07h15 – 16h00) Monday to Friday (Office of the Chief Financial Officer).

An invitation is hereby made in terms of Section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires may lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the valuation within the abovementioned period.

Attention is specifically drawn to the fact that an objection must be in relation to a specific individual property and not against the valuation roll as such.
