

PUBLIC NOTICE FOR CALLING FOR INSPECTION OF THE SUPPLEMENTARY VALUATION ROLL AND THE LODGING OF OBJECTIONS (PERIOD 2013 / 2014)

Notice is hereby given in terms of Section 49 (1)(a)(i) read together with Section 78(2) of the Local Government: Municipal Property Rates Act 2004 (Act No 6 of 2004), that the Supplementary Valuation Roll for the financial years 2013/2014 is open for public inspection at Govan Mbeki Municipality Offices, Horwood Street, Secunda at rooms 221 and 224 as well as at the pay points in Bethal, eMbalenhle, Kinross and Leandra during normal office hours from Friday, 18 April 2014 until Friday, 30 May 2014. In addition the Supplementary Valuation Roll is available on the website: www.govanmbeki.gov.za.

An invitation is hereby made in terms of Section 49(1)(a)(ii) read together with Section 78(2) of the Local Government: Municipal Property Rates Act 2004 (Act No 6 of 2004) that any owner of property or any other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from the Supplementary Valuation Roll, within the above mentioned period.

Attention is specifically drawn to the fact that, in terms of Section 50(2) of the Local Government: Municipal Property Rates Act 2004 (Act No 6 of 2004) an objection must be in relation to a specific individual property, not against the Supplementary Valuation Roll as such.

In accordance with Section 50(3) of the Local Government: Municipal Property Rates Act 2004 (Act No 6 of 2004) only objectors who are unable to read or write will be assisted by officials.
