

#### **NOTICE 187 OF 2014**

# DIRECTIONS ISSUED IN TERMS OF SECTION 41(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002) REGARDING THE DECLARED PROVINCIAL STATE OF DISASTER

- I, Simon Piet Dolman Skhosana, Member of the Executive Council responsible for local government in the Mpumalanga Province, hereby issue the following directions in terms of section 41(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002), as authorised by the Premier in terms of the Government Gazette Notice No 2287 of 25 April 2014, matters hereafter referred to as directions in managing the state of Disaster in the Province:
- (a) The release of any available resources of the provincial government including;
  - (i) Stores relevant for evacuation, mitigation and recovery for humanitarian purposes.
  - (ii) Equipment and vehicles that are necessary for the emergency evacuation, mitigation and rehabilitations may be determined through the Provincial Disaster Management Centre.
  - (iii) Facilities and provisions of the necessary co-ordination venues for proper disaster management facilitation as may be required by the Provincial Disaster Management Centre
- (b) The release of personnel of a provincial organ of state for the rendering of emergency services as may be directed by the Provincial Disaster Management Centre:
- (c) The implementation of all or any of the provisions of a provincial disaster management plan that are applicable in the circumstances;

- (d) The evacuation to temporary shelters of all or part of the population from the disaster-stricken or threatened area if such action is necessary for the preservation of life.
  - (i) Temporary shelters shall include but not limited to:
    - Collapsible structures as agreed with the Department of Human Settlement and the Provincial Disaster Management Centre,
    - Permanent structures such as municipal amenities e.g. community halls, civic centres as well as churches and other Non-Governmental Organisations (NGO) centres,
    - Any other formal temporary structure that is agreed to by the Department of Human Settlement and the Provincial Disaster Management Centre
- (e) The regulation of traffic to, from or within the disaster-stricken or threatened area in consultation with the Department of Community Safety, Security and Liaison, South African Police Services, the Provincial Disaster Management Centre and other Law Enforcement Agencies.
- (f) The movement of persons and goods to, from or within the disaster-stricken or threatened area in consultation with all Disaster Management Structures, the Provincial Disaster Management Centre, the Department of Community Safety, Security and Liaison, South African Police Services and other Law Enforcement Agencies.
- (g) Control and occupancy of premises in the disaster-stricken or threatened area may be in consultation with all Disaster Management Structures, the South African Police Services, the Department of Community Safety, Security and Liaison, the South African Defence Force, the Provincial Disaster Management Centre and other Law Enforcement Agencies.
- (h) Maintenance or installation of temporary lines of communication to, from or within the area in consultation with the Provincial Disaster Management Centre.

- (i) The dissemination of information required for dealing with the disaster shall vest with the Provincial Disaster Management Centre.
- (j) Emergency procurement procedures shall be followed in line with the Supply Chain Policies of both the Provincial and Local Government to take extra-ordinary actions to expedite the procurement of the required goods and services.
- (k) Facilitation of responses and post disaster recovery and rehabilitation by all relevant sectors through the Provincial Disaster Management Centre.
- (I) All sectors and persons shall abide by the directions and guidance as shall be reviewed from time to time by the Provincial Disaster Management Centre until such time that the declaration of such disaster has duly lapsed.
