

### FEES, ENTRY REQUIREMENTS, ASSESSMENT, MODERATION AND RECOGNITION OF CURRENT PRIOR & CURRENT LEARNING

I, VR Shongwe, Member of the Executive Council responsible for Community Safety, Security and Liaison in Mpumalanga Traffic Training College hereby, in terms of South African Qualification Authority Act, RTMC Act, 1999 (Act 20 of 1999) and National Road Traffic Act, 1996 (Act 93 of 1996) / Road Traffic Act, 1989, (Act 29 of 1989)

#### SCHEDULE

#### Definitions

- 1. In these Regulations, unless the context indicates otherwise -
  - "Mpumalanga policy document for Mpumalanga Traffic Training College"

The policy compliments the National Road Traffic Act, 1996 (Act 93 of 1996. Chapter II of the Act deals with the approval of Training Centres, training of authorised officers, examiners of vehicles and examiners for driving licences and appointment and grading of authorised officers.

"the national regulations" means regulations enacted under the National Act; and "the Road Traffic Act" means the Mpumalanga Road Traffic Act, 1998 (Act No. 4 of 1998).

#### Fees charged

- 2. (1) The fees charged in terms of the Mpumalanga Traffic Training College policy
  - (2) The fees charged in terms of Mpumalanga Traffic Training College policy for training traffic officials shall be as indicated in Government Gazette no.: ..... of 1 April 2021

#### Apportionment of fees

- 3. For the purpose of this Regulation, the expression -
  - (a) "MTTC" means the Mpumalanga Traffic Training College
  - (b) "Prospective clients" Municipalities, Provincial Departments and Public Entities requiring

MTTC to train traffic officials for them

- (c) "Department" means Department of Community Safety, Security and Liaison: Mpumalanga Province;
- (d) "Head of Department" means the Head of Department of the Department of Community, Safety, Security and Liaison: Mpumalanga Province;
- (e) "municipality" means a municipality referred to in section 155 of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996); and
- (f) "Road Traffic Acts" means the National Road Traffic Act, 1996 (Act No. 93 of 1996) and the Mpumalanga Road Traffic Act, 1998 (Act No. 4 of 1998).

Mpumalanga Traffic Training College is (MTTC) is accredited by Safety and Security Sector, Education and Training Authority (SASSETA), National Regulator for Compulsory Specifications (NRCS), South African Police Service (SAPS) and Quality Council for Trades and Occupations for the following courses

#### 3.1 QUALIFICATIONS AND COURSES PROVIDED BY MTTC

- 1. Basic Traffic Officers Training Course NQF level 4 (TO)
- 1.1. Firearm Training
- 1.2. Examiner of Vehicles (EOV) & Examiner for Driving Licences (EDL)
- 1.3. Evidential Breath Alcohol Testing (EBAT)
- 1.4. Advanced and Defensive Driving
- 1.5. All Evaluations and Moderations are conducted by Road Traffic Management Corporation and SASSETA

#### ENTRY REQUIREMENTS FOR QUALIFICATIONS / COURSES

Please note MTTC does not accept walk-ins All applicants must be employed by a local Authority, Provincial Authority or Private Test Station.

#### 4. ENTRY REQUIREMENTS

Before a student is allowed unto a specific course, he / she must comply with the following minimum entry requirements:

#### 4.1 BASIC TRAFFIC OFFICER'S COURSE

The following requirements will apply before a person is allowed into the above course:

- Minimum educational qualification is Grade 12 or equivalent.
- Code B Driving licence (manual or transmission).
- The applicant must be employed by a Provincial Authority or Local Authority or any other authorized institution.
- No criminal record.
- Medical Certificate as a proof that a person may do strenuous physical activities.
- Applicants shall not be older than 35 years of age.

NB: Physical fitness is essential for practical training and drilling activities.

#### 4.2 COURSE FOR EXAMINER FOR DRIVING LICENCES

- Minimum educational qualification of grade 12 or equivalent.
- No Criminal record
- The applicant must be employed by a Provincial Authority or Local Authority
- The applicant must be in transmission in order to indicate hereunder possession of the following driving licenses, manual attend and be trained in the different modules as
  - -Grade A: Codes EC and A
  - Grade B: Code EC
  - Grade C: Code B and A
  - Grade D: Code BGrade F: None
  - Grade L: None

The course for examiners of driving licenses is progressive of nature and any person applying to attend only a particular grade (module) of the entire course other than the most basic grade must produce proof of having completed the grades which proceed the grade which he has been applied for.

#### 4.3 COURSE FOR EXAMINER OF VEHICLES

- Minimum education of grade 10 or equivalent
- No criminal record
- The applicant must be employed by a Provincial Authority or Local Authority or private test station
- The applicant must be in a possession of the applicable driving licences (manual transmission) to attend the different grades of training as prescribed in the National Road Traffic Act, 1996 (Act 93 of 1996)

#### 4.4 ANY OTHER CREDIT OR NON-CREDIT BEARING COURSE

The requirements for any other courses presented at the Mpumalanga Traffic College will be dictated by the relevant Unit Standard or as agreed upon in conjunction with RTMC where applicable.
