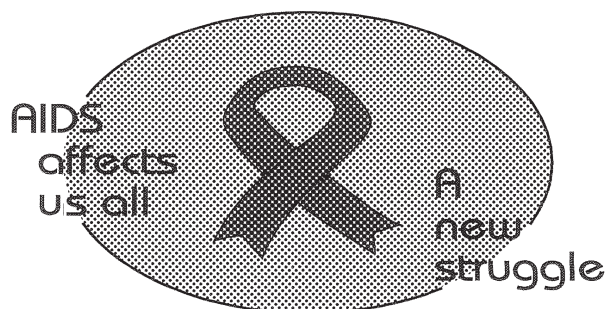

(ACT NO. 4 OF 1998)****MPUMALANGA PROVINCIAL ROAD TRAFFIC REGULATIONS**

I, **VR Shongwe**, Member of the Executive Council responsible for Community, Safety, Security and Liaison hereby, in terms of section 25 of the Mpumalanga Road Traffic Act, 1998 (Act No. 4 of 1998), make the Regulations set out in the Schedule.

Definitions

1. In these Regulations, unless the context indicates otherwise -

“Centre” means a driving license-testing Centre in the Mpumalanga Province.

“the Department” means the Department of Community Safety, Security and Liaison in the Mpumalanga Province and is referred to as a Principal in terms of this Regulations.

“Head of Department” means the Head of Department of Community Safety, Security and Liaison: Mpumalanga Province.

“Municipality” means a municipality referred to in section 155 of the Constitution of the Republic of South Africa, 1996 and is referred to as an Agent in terms of this Regulations.

“Principal-agent arrangements” An arrangement between an agent and a principal through a binding arrangement, to undertake transactions with third parties on behalf of the Department.

“Registering authority” means an registering authority as defined in the national regulations.

“The National Act” means the National Road Traffic Act, 1996 (Act No. 93 of 1996)

“The National Regulations” means regulations enacted under the National Road Traffic Act; and

“The Provincial Act” means the Mpumalanga Provincial Road Traffic Act, 1998 (Act No. 4 of 1998).

Fees charged

- 2 (a) The fees payable in respect of the registration and licensing of motor vehicles in the Province other than the fees referred to in sub-regulation (2), shall be as indicated in Schedules 1 and 2 hereto
- (b) The fees charged in terms of section 81 of the National Road Traffic Act for a permit for abnormal vehicles and the transportation of abnormal loads shall be as indicated in a notice published by the Minister.

Apportionment of fees for principal-agent arrangement.

3. (a) An agent collecting fees must pay the said fees, as indicated on Schedule 1 and 2, into the relevant Principal's revenue account not later than the 21st day of the month following the month in which such fees were collected irrespective of whether that day is a Saturday, Sunday or public holiday.
- (b) if such fees from an agent is not paid within the period, such fees will be subject to interest charged at the rate determined by the Minister of Finance in terms of section 80 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), calculated from the first day of the month in which the fees are payable up to and including the day preceding the actual payment.
- (c) An agent must compile a reconciliation of the fees collected per calendar month in the form as determined by the Head of Department and forward such reconciliation to the principal with fees which were collected as per service level agreement not later than the 15th day of the month following the month in which such fees were collected irrespective of whether that day is a Saturday, Sunday or public holiday.
- (d) An Agents' commission is VAT inclusive.
- (e) The agent - South African Post Office's apportionment and other requirements is as contained in the memorandum of agreement signed by the principal.
