

MPUMALANGA GAMING ACT (ACT 5 OF 1995), AS AMENDED APPLICATION FOR A TOTALISATOR AGENCY LICENSE

Notice is hereby given that 4 Racing (Pty) Ltd t/a TAB of No 14 Turf Club Street, Turffontein, 2190 lodges application to Mpumalanga Gambling Board for an amendment of Totalisator license for the following site:

Stand No 1546, Kwaggafontein A, Thembisile Hani, Nkangala, Mpumalanga

The purpose of this application is to obtain the license and operate the Totalisator Agency at the abovementioned premises in Mpumalanga Province. The proposed Agent is USA Bar (Pty) Ltd t/a Kwaggafontein TAB Agency, as represented by Hlekwa Paulus Mahlangu.

Application will be open to public inspection at the offices of the Board from 15 February 2023. Attention is directed to the provisions of section 26 of the Mpumalanga Gambling Act, 1995 (Act 5 of 1995) as amended, which makes provision for the lodging of written objections in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Mpumalanga Gambling Board, First Avenue, White River, South – Africa within one month from 15 February 2023.

Such representations shall contain at least the following information:

- (a) The name of the applicant to which representations relate
- (b) The ground or grounds on which representations are made
- (c) The name, address, telephone, email or fax number of the person submitting the representations.
- (d) Whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) Whether or not they wish to make oral representations at the hearing of the application.
