SOCIO-ECONOMIC IMPACT OF GAMBLING IN MPUMALANGA

The Mpumalanga Economic Regulator ("MER") is established in terms of section 2 of the Mpumalanga Economic Regulator Act, 2017 (Act No. 2 of 2017), to regulate the gambling and liquor industries in Mpumalanga. The MER invites proposals to conduct research on the socio-economic impact of gambling in Mpumalanga.

This tender will be evaluated using a two-stage bidding process:

1. Functionality
2. The 80\20 preference point system as prescribed in the Preferential Procurement Policy Framework Act., 2000 (PPPFA) and Preferential Procurement Regulations, 2022 (PPR2022). 80 Points representing price and 20 points representing specific goals. Only bidders who meet the minimum requirement in the functionally criterion will be considered for this phase.

A compulsory briefing session will be held on 13 April 2023 11:00am at MER Building, First Avenue, White River, 1240, Mpumalanga Province, South Africa.
