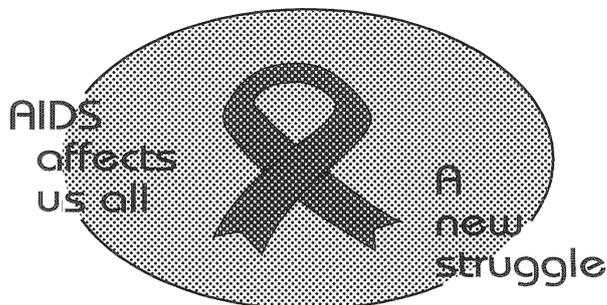

Annexure A**Ref No: 12/3/373****EXECUTIVE SUMMARY****APPLICATION FOR AN EXPLORATION RIGHT IN TERMS OF SECTION 79 OF THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 (ACT NO. 28 OF 2002) (MPRDA): IN RESPECT OF VARIOUS FARMS IN THE MAGISTERIAL DISTRICTS OF BALFOUR, STANDERTON AND HOVELDRIFT, MPUMALANGA PROVINCE**

On the 04th of April 2023, Imbokodo Exploration and Production (Pty) Ltd (“Imbokodo”) lodged an application for an Exploration right in terms of section 79 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (“the Act”) In respect of various farms in the Magisterial Districts of balfour, standerton and hoeveldrift, Mpumalanga Province. The sketch for this area is shown below as **Figure 1**.

The exploration right application in question was preceded by the desktop geological study of the area undertaken by Imbokodo to assess the geological suitability of the area for the occurrence of natural gas resources. The results from the said desktop studies were found to be encouraging, and thus, Imbokodo intends to continue to assess the hydrocarbon potential of the area, through undertaking the following activities which form part of their exploration work programme:

- Analysis of the historical data in the area including borehole cores mainly from mineral prospecting and mining boreholes to better understand the geology of the area as well as to build the geological model of the area;
- Undertake desktop studies to understand the petroleum systems in the area; and
- Undertake field trips in the area to better understand and validate the geology in the area.

All the exploration activities to be undertaken by Imbokodo during their three-year exploration term will be non-invasive, meaning that the ground will not be disturbed. However, depending on the results from the desktop studies indicated above, Imbokodo may acquire airborne geophysical surveys such as gravity and magnetics to map the subsurface structures which could be containing natural gas resources. These surveys will still not have any impact on the ground however, the necessary potential impact studies of these surveys will be undertaken during the environmental permitting processes as indicated below.

ASSESSMENT OF APPLICATION FOR PURPOSE OF APPROVAL/REFUSAL

The above-mentioned application was accepted on the 25th of April 2023, it is now being subjected to further assessments of several aspects of the MPRDA prior to a decision regarding the approval or refusal thereof. The requirements in terms of the MPRDA, National Environmental Management Act, 1998 and other relevant and applicable legislation will be considered. Amongst other factors that will be considered are:

- Financial and technical ability of the Applicant to conduct the proposed exploration activities optimally;
- Compliance with all the requirements for the granting of Environmental Authorisation;
- Meaningful consultation with interested and affected parties;
- If the granting of the exploration right will substantially and meaningfully expand opportunities for historically disadvantaged persons; and
- If the granting will promote employment and advance social and economic welfare of South Africans.

It is worth noting that the recommendation to grant or refuse the exploration right will only be made after the decision on an application for an environmental authorisation in terms of the Environmental Impact Assessment Regulations, 2014 is taken.

Imbokodo Exploration and Production (Pty) Ltd has been advised to commence with the application for the environmental authorisation and interested and affected persons will have further opportunity to comment during the environmental impact assessment process.

UITVOERENDE OPSOMMING**AANSOEK OM 'N VERKENNINGSREG VIR PETROLEUM INGEVOLGE ARTIKEL 79 VAN DIE WET OP MINERAAL- EN PETROLEUMHULPBRONNEONTWIKKELING, 2002 (WET NR. 28 VAN 2002) (MPRDA): TEN OPSIGTE VAN VERSKEIE PLASE IN DIE VERSKEIE PLASE IN BALFOUR, STANDERTON EN HOEVELDRIFT, MPUMALANGA PROVINSIE**

Op die 4ste April 2023 het Imbokodo Exploration and Production (Edms) Bpk ("Imbokodo") 'n aansoek om 'n eksplorasiereg ingevolge artikel 79 van die Wet op die Ontwikkeling van Minerale en Petroleumhulpbronne, 2002 (Wet No. 28 van 2002) ("die daad") Ten opsigte van verskeie plase in die Landdrostdistrikte van Balfour, Standerton en Hoeveldrift, Mpumalanga Provinsie. Die skets vir hierdie area word hieronder as **Figuur 1** getoon.

Die betrokke eksplorasiereg-aansoek is voorafgegaan deur die lessenaargeologiese studie van die gebied wat deur Imbokodo onderneem is om die geologiese geskiktheid van die gebied vir die voorkoms van aardgashulpbronne te bepaal. Daar is gevind dat die resultate van die genoemde lessenaarstudies bemoedigend is, en dus beoog Imbokodo om voort te gaan om die koolwaterstofpotensiaal van die gebied te evalueer deur die volgende aktiwiteite te onderneem wat deel vorm van hul eksplorasiewerkprogram :

- Ontleding van die historiese data in die gebied insluitend boorgatkerne hoofsaaklik van mineraalprospektering en mynboorgate om die geologie van die gebied beter te verstaan asook om die geologiese model van die gebied te bou ;
- Onderneem lessenaarstudies om die petroleumstelsels in die area te verstaan; en

- Onderneem velduitstappies in die area om die geologie in die area beter te verstaan en te bekragtig.

Imbokodo onderneem word gedurende hul eksplorasietermyn van drie jaar sal nie-indringend wees, wat beteken dat die grond nie versteur sal word nie. Afhangende van die resultate van die lessenaarstudies wat hierbo aangedui is, kan Imbokodo egter geofisiese opnames in die lug soos swaartekrag en magnetika verkry om die ondergrondse strukture wat moontlik aardgasbronne bevat, te karteer. Hierdie opnames sal steeds geen impak op die grond hê nie, maar die nodige potensiele impakstudies van hierdie opnames sal onderneem word tydens die omgewingspermitteprosesse soos hieronder aangedui.

ASSESSERING VAN AANSOEK VIR DOEL VAN GOEDKEURING/WEEIERING

Die bogenoemde aansoek is op 25 April 2023 aanvaar · dit word nou onderwerp aan verdere assesserings van verskeie aspekte van die MPRDA voor 'n besluit rakende die goedkeuring of weiering daarvan. Die vereistes ingevolge die MPRDA, Wet op Nasionale Omgewingsbestuur, 1998 en ander relevante en toepaslike wetgewing sal oorweeg word. Onder ander faktore wat oorweeg sal word, is:

- Finansiële en tegniese vermoë van die Aansoeker om die voorgestelde eksplorasië-aktiwiteite optimaal uit te voer;
- Voldoening aan al die vereistes vir die toekenning van Omgewingsmagtiging ;
- Sinvolle konsultasie met belanghebbende en geaffekteerde partye;
- As die toekenning van die eksplorasiereg geleenthede vir histories benadeelde persone wesenlik en sinvol sal uitbrei; en
- As die toekenning indiensneming sal bevorder en sosiale en ekonomiese welsyn van Suid-Afrikaners sal bevorder.

Dit is opmerklik dat die aanbeveling om die eksplorasiereg toe te staan of te weier eers gemaak sal word nadat die besluit oor 'n aansoek om 'n omgewingsmagtiging ingevolge die Omgewingsimpakstudieregulasies, 2014 geneem is. Imbokodo






