

### FORMATION, DUTIES AND RESPONSIBILITIES OF THE HOME-OWNER'S ASSOCIATION

The township owner shall establish a legal entity / home-owner's association that shall be properly and legally constituted to remain or become the township owner.

All owners of erven in the township, as well as in the development of which the township forms a part, shall be obliged to become and remain members of the Association and shall be subject to its Memorandum of Incorporation until such owners legally cease to be owners.
