### PROCLAMATION

LOCAL GOVERNMENT TRANSITION ACT, 1993  
(ACT NO. 209 OF 1993)

**No. 18/1995**

#### NIEUWOUDTVILLE FORUM AREA

By virtue of the powers vested in me by section 10 (1) of the Local Government Transition Act, 1993 (Act No. 209 of 1993), and, with the concurrence of the Provincial Committee for Local Government contemplated by section 3 (1) of the said Act. I hereby make the following enactments which shall, unless otherwise specified take effect on the date on which this Proclamation comes into operation:

1. The local government bodies within the forum area and listed below are hereby dissolved:
  - (a) Nieuwoudtville Municipality.
  - (b) Nieuwoudtville Management Committee.
2. The term of office of all the Councillors and Management Committee Members of the local government bodies referred to in paragraph 1 above, is hereby terminated.
3. There is hereby established a transitional local council as referred to in section 7 (1) (b) of Act No. 209 of 1993, under the name of the "Nieuwoudtville Transitional Local Council" which shall—
  - (a) consist of the persons whose names are listed in the Schedule hereunder; and
  - (b) govern and represent the Nieuwoudtville Transitional Local Council in accordance with the provisions of the Municipal Ordinance, 1974 (Ordinance No. 20 of 1974)
4. The number of seats for the Nieuwoudtville Transitional Local Council is hereby determined as 16 (sixteen).
5. The persons in the service of the local government bodies dissolved in terms of paragraph 1 of this Proclamation are transferred to the service of the Nieuwoudtville Transitional Local Council subject to conditions not less favourable than those under which they served with their respective former local government bodies.
6. The by-laws of the local government bodies dissolved in terms of paragraph 1 above shall continue to be of full force and effect in what was the area of jurisdiction of each such body until repealed or amended.

By virtue of the powers vested in me by section 10 (1) of the Local Government Transition Act, 1993 (Act No. 209 of 1993), and, with the concurrence of the Provincial Committee for Local Government contemplated by section 3 (1) of the said Act, I hereby make the following enactments which shall, unless otherwise specified take effect on the date on which this Proclamation comes into operation:

5. The persons in the service of the local government bodies dissolved in terms of paragraph 1 of this Proclamation are transferred to the service of the Kuruman Transitional Local Council subject to conditions not less favourable than those under which they served with their respective former local government bodies.
6. The by-laws of the local government bodies dissolved in terms of paragraph 1 above shall continue to be of full force and effect in what was the area of jurisdiction of each such body until repealed or amended.
7. With effect from the date on which this Proclamation comes into operation, the assets, liabilities, rights and obligations of the Kuruman Municipality and the Wrenchville Management Committee shall devolve upon, be assigned to and become the assets, liabilities, rights and obligations of the transitional local council.
