DEFINITION

- (d) a valid travel document issued in terms of any law of the Republic of Transkei, Bophuthatswana, Venda and Ciskei; or
- (e) a valid book of life issued by the former republic of—
 - (i) Ciskei in terms of Act 15 of 1981; or
 - (ii) Transkei in terms of Act 24 of 1976; or
 - (iii) Bophuthatswana in terms of Act 12 of 1978; or
 - (iv) Venda in terms of Act 6 of 1980;"

(d) The Premier, authority, body or person contemplated in paragraph (c) shall have the right to conduct inspections at or in the offices of any transitional authority, local government body or revision court to ascertain the state of affairs in respect of the election or any part thereof and to peruse and make extracts from files, books, registers and records which may have a bearing on the election.
(e) Any authority, body or person appointed in terms of paragraph (c) shall submit a written report to the Premier when required by the Premier, setting out the state of affairs in respect of the election or any part thereof in one or more transitional authority, local government body or revision court and shall make recommendations in respect thereof.".
