**PROCLAMATION · PROKLAMASIE****PROCLAMATION****No. 1, 1996****PROVINCE OF NORTHERN CAPE****ROADS ORDINANCE, 1976 (ORDINANCE 19 OF 1976)****DIAMANTVELD REGIONAL SERVICES COUNCIL: DIVERSION, DECLARATION AND CLOSURE OF PUBLIC ROADS**

1. Under sections 3 and 4 of the Roads Ordinance, 1976 (Ordinance 19 of 1976) and section 7 of the Advertising on Roads and Ribbon Development Act, 1940 (Act 21 of 1940), I hereby—

1.1 declare that a portion of  $\pm 5,7$  km of Divisional Road 3024 within the Diamantveld Regional Services Council area, as indicated by means of an unbroken green line marked A-B on plan RL.41/40, shall be diverted and that the location and route of the diversion shall be as described in Schedule I and as indicated by means of a broken green line marked A-C-B on said plan RL.41/40;

1.2 declare that the portion of  $\pm 6$  km of Minor Road 22/2 within the said Regional Services Council area, as indicated by means of an unbroken blue line marked U-K on plan RL.41/40, shall be diverted and that the location and route of the diversion shall be as described in Schedule III(1) and as indicated by means of a broken blue line marked U-V on said plan RL.41/40;

1.3 declare that the portion of  $\pm 4,6$  km of Minor Road 17/2 within the said Regional Services Council area, as indicated by means of an unbroken blue line marked X-Y on plan RL.41/40, shall be diverted and that the location and route of the diversion shall be as described in Schedule III(2) and as indicated by means of a broken blue line marked X-W on said plan RL.41/40;

1.4 declare that the road described in Schedule II and situated within the said Regional Services Council area, shall be a public road and that the location and route thereof shall be as indicated by means of a broken blue line marked I-N-N1 on plan RL.41/40 and I hereby classify such public road as a minor road;

1.5 declare that the existing public roads and portions of the existing public roads described in Schedule IV and situated within the said Regional Services Council area, the locations and routes of which are as indicated by means of unbroken blue lines marked F-G, J-O-P, A-C, E-D, H-I-J-K-L-L1-M and Q-R-S-T on plan RL.41/40, shall be closed;

1.6 proclaim the road described in Schedule I to be a building restriction road for the purposes of said Act 21 of 1940; and

1.7 withdraw Proclamation 318 of 1979, dated 9 November 1979, in so far as it applies to the proclamation as building restriction road of the portion of the public road mentioned in paragraph 1.1 above and marked A-B on said plan RL.41/40.

2. Plan RL.41/40 is filed in the offices of the Department of Transport, Post Office Building, Market Square, Kimberley, and the Diamantveld Regional Services Council, Kimberley.
