ROADS ORDINANCE, 1976 (ORDINANCE 19 OF 1976)

**NAMAQUALAND REGIONAL SERVICES COUNCIL: ALTERATION TO CLASSIFICATION OF  
MINOR ROAD 34 AND A PORTION OF DIVISIONAL ROAD 2962**

1. Under section 4 of the Roads Ordinance, 1976 (Ordinance 19 of 1976), and section 7 of the Advertising on Roads and Ribbon Development Act, 1940 (Act 21 of 1940), I hereby—

1.1 alter the classification of the public road described in Schedule I and situated in the Namaqualand Regional Services Council area, the location and route of which are indicated by means of a broken green line marked A—B on plan RL.40/37, from a minor road to a divisional road;

1.2 proclaim the road described in Schedule I to be a building restriction road for the purposes of the said Act 21 of 1940;

1.3 alter the classification of the portion of the public road described in Schedule II and situated in the said Regional Services Council area, the location and route of which are indicated by means of a broken blue line marked B—C on said plan RL.40/37, from a divisional road to a minor road; and

1.4 withdraw Proclamation 318 of 1979, dated 9 November 1979, in so far as it applies to the proclamation as building restriction road of the portion of road described in Schedule II.

2. Plan RL.40/37 is filed in the offices of the Department of Transport, Post Office Building, Market Square, Kimberley, and the Namaqualand Regional Services Council, Springbok.
