The Premier has approved the subjoined by-law framed by the Municipal Council of Calvinia:

**CALVINIA MUNICIPALITY: BY-LAW REGARDING THE PAYMENT OF SUNDY ACCOUNTS****Definitions**

## 1. In this by-law—

**"Council"** means the Municipal Transitional Council of Calvinia or its successor-in-title and includes any employee of the Council exercising powers or performing duties or functions delegated to him by the Council;

**"month"** means a calendar month;

**"standard rate"** means the same as the connotation placed on it by section 2 (lxxxix) of the Municipal Ordinance (Ordinance No. 20 of 1974);

**"sundry service"** means any service rendered by the Council or on behalf of the Council in respect of which compensation is payable to the Council and which payment is not regulated by any other by-law, law or ordinance.

**Payment of sundy accounts**

2. The amount due in respect of any sundy service rendered shall be payable monthly on or before the 30th day of the month following the month during which the first account has been rendered. If such amount is not paid by such day, the amount due shall be subject to an interest which shall be charged at the prevailing standard rate. Such interest is calculated monthly on a basis of compound interest till the account is fully paid.

**"diverse diens"** enige diens deur die Raad of namens die Raad gelewer ten opsigte waarvan gelde aan die Raad betaalbaar is en ten opsigte waarvan betaling nie deur enige ander verordening, wet of ordonnansie gereël word nie;

**"maand"** 'n kalendermaand;

**"raad"** die Munisipale Oorgangsraad van Calvinia of sy opvolger in reg en omvat dit enige werknemer van die Raad wat bevoegdhede uitoefen of pligte of funksies vervul wat deur die Raad aan hom gedelegeer is;

2. Die bedrag verskuldig ten opsigte van enige diverse diens wat gelewer is, is maandeliks betaalbaar voor of op die 30ste dag van die maand wat volg op die maand waarin die eerste rekening deur die Raad gelewer is. Indien sodanige bedrag nie teen sodanige dag betaal word nie, is die verskuldigde bedrag onderworpe aan 'n rente wat bereken word teen die heersende standaardkoers. Sodanige rente word maandeliks saamgesteld bereken totdat die rekening ten volle vereffen is.

The by-law promulgated under Provincial Notice 840 dated 14 November 1980 is hereby amended as follows:

By the substitution for section 5 (a) of the following section:

**"Payments of accounts**

5. (a) The amount due in respect of water supplied shall be payable monthly on or before the 15th day of the month following the month during which the water was supplied. If such amount is not paid by such day, the amount due shall be subject to a surcharge as fixed by the Council by special resolution. When an acceptable arrangement for the payment of an overdue account is made with the town treasurer, such overdue account is transferred to a separate

debtor account which shall not be subject to further surcharge. Regular payment of current monthly accounts shall be regarded as an integral part of the beforementioned arrangement and if the agreed arrangement is not complied with, the Council may transfer the overdue account to the original account in which case it shall be subject to the fixed surcharge again. The Council reserves the right to disconnect the supply on any day after the last day of the month following the month during which the water was consumed if the account was not paid in full on the said last day.”.
