**BO-KAROO DISTRICT COUNCIL: CLOSING OF A PORTION OF DIVISIONAL ROAD 2447 AND
MINOR ROADS 44H AND 55H**

Under section 3 of the Roads Ordinance, 1976 (Ordinance No. 19 of 1976), I hereby declare that the portion of the existing divisional road and the existing public roads described in the Schedule and situated within the Bo-Karoo District Council area, the locations and routes of which are as indicated by means of unbroken green line AB and unbroken blue lines marked CD and EF on Plan RL. 96/1, which is filed in the office of the Chief Director: Department of Transport, 22 Fabricia Road, Kimberley, and the Bo-Karoo District Council, De Aar, shall be closed.

A road starting at its junction with Divisional Road 2448 on the Commonage of Hanover and from there in a north-westerly direction across said Commonage of Hanover and the farms Uile Fontyn, Vogelfontein, Jaag Fountain, Vlake and Nuwefontein to its junction with Divisional Road 2448 on the farm Nuwefontein, a distance of approximately 30 kilometres.
