

AMENDMENT OF THE ROAD TRAFFIC REGULATIONS: INCREASE IN THE TARIFFS IN RESPECT OF MISCELLANEOUS FEES

I, John Block, under the powers vested in me by Proclamation No. R. 60 of 1996 and subject to the provisions of the Northern Cape Delegation of Functions Act, 1994 (Act No. 4 of 1994), hereby amend, with effect from 1 August 1999, the miscellaneous fees as set out in Schedule 1 of the Road Traffic Regulations promulgated in terms of section 132 (1) (w) of the Road Traffic Act, 1989, in so far as it is applicable in the Province of the Northern Cape, by the insertion of the following items after item 14 of the Schedule:

PERSONALISED REGISTRATION NUMBER SYSTEM FOR THE NORTHERN CAPE PROVINCE

I, John Block, hereby declare in terms of the powers vester in me under regulation 199A (1) of the Road Traffic Regulations, promulgated in terms of the Road Traffic Act, 1989 (Act No. 29 of 1989), that a system of personalised registration numbers, consisting of—

- (a) a maximum of six letters, followed by the letters 'NC';
- (b) a combined maximum of six letters and figures, followed by the letters 'NC'; or
- (c) a maximum of six figures, followed by the letters 'NC';
- (d) specific numbers, chosen by the applicants therefore, of the format "FFFLLLNC", where "F" represents a figure and "L" represents a letter,

but excluding all words, letters or combinations of figures and letters deemed to be offensive, will come into effect in the Northern Cape Province on 1 August 1999: Provided that a personalised registration number of the type referred to in paragraph (b) shall not consist of three consecutive letters, followed by three consecutive figures, followed by the letters 'NC'.
