DETERMINATION OF SALARIES AND ALLOWANCES OF THE PREMIER, MEMBERS OF EXECUTIVE COUNCILS AND MEMBERS OF PROVINCIAL LEGISLATURE

In terms of section 2 (1) of the Northern Cape Payment of Members of the Provincial Legislature Act, No. 5 of 1994 (hereinafter referred to as the Act) read with section 125 (2) (a) of and item 2 (1) of Schedule 6 of the Constitution of the Republe of South Africa, Act No. 108 of 1996 (hereinafter referred to as the Constitution), and having given due regard to the recommendations of the Commission on Remuneration of Representatives as published in Government Notice No. R. 112, 1999, I, M. E. Dipico, Premier of the Northern Cape Province, hereby determine the salaries and allowances to be paid annually to Members and office-bearers of the Provincial Legislature specified in Column 1 of the Schedule and who, for the purpose of this determination, are categorised under the grades specified in Column 1, to be as specified in Column 2 of the Schedule.

UPPER LIMIT OF STATE'S CONTRIBUTION TOWARDS A REGISTERED PENSION FUND AND MEDICAL AID SCHEME OF WHICH PREMIER'S MEMBERS OF EXECUTIVE COUNCILS AND MEMBERS OF PROVINCIAL LEGISLATURES ARE MEMBERS

In terms of section 8 (3) (a) and 8 (4) (a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) ("the Remuneration Act"), I hereby determine that the upper limit of the contribution to be made monthly by the State to a pension fund of which a Premier, a member of an Executive Council of a Province or a member of a provincial legislature, is a member, shall be as set out in Rule 4.2 of the Rules of the Political Office Bearers Fund, registered in terms of the Pension Funds Act, 1956 (Act No. 24 of 1956).

In terms of the sections 9 (3) (a) and 9 (4) (a) of the Remuneration Act, I hereby determine that the upper limit of the contribution to be made by the State to a medical aid scheme of which a Premier, a member of an Executive Council of a province or a member of a provincial legislature, is a member, shall be equal to double the amount payable by the member concerned to that medical aid scheme in terms of the rules of the scheme.
