Chapter 1

Definitions

1. In these regulations any word or expression to which a meaning has been assigned in the Northern Cape Gambling Levies Act, 2009 (Act 4 of 2009) and Northern Cape Gambling Act 2008 (Act 3 of 2008), shall have the meaning so assigned to it and, unless the context otherwise indicates -

Act means the Northern Cape Gambling Levies Act, 2009 (Act 4 of 2009)

Chief Executive Officer means the chief executive officer appointed in terms of section 10(1) of the Northern Cape Gambling Act, 2008 (Act 3 of 2008)

Table game means a gambling game normally played on a table

Chapter 2

Gambling levy

- 2. The gambling levy payable in terms of section 2 of the Act shall be paid as stipulated in schedule 1 of these regulations.
- **3.** The gambling levy not payable in accordance with sub-regulation 2 must be paid out of the gross gambling revenue of a game as follows:
- (1) For each table game, gross gambling revenue equals the closing bankroll plus credit slips for cash, chips or tokens returned to the casino cage, plus drop, less opening bankroll and fills to the table.
- (2) For each gambling machine, gross gambling revenue equals metered win or loss.
- (3) For each card game and any other game in which the licensee is not a party to a wager, gross gambling revenue equals money received by the licensee as compensation for conducting the game.

Penalties for late payment of gambling levy

4. If the gambling levy payable in terms of section 2 of the Act is not paid in accordance with the provisions of section 3 of the Act, the licensee shall pay a penalty on the amount of any outstanding levy at a rate of ten percent of the levy for each week or part of the week during which the levy remains unpaid: Provided that the penalty shall not exceed twice the amount of the levy in respect of which such

penalty is payable: Provided further where the Chief Executive Officer is satisfied that the failure on the part of any licensee to make payment of the levy within the prescribed period was not due to an intent to avoid or postpone liability for payment of the amount due, the Chief Executive Officer may remit in whole or in part any penalty payable in terms of these regulations.

Title and commencement

These regulations shall be called the Northern Cape Gambling Levies Regulations and shall come into operation on the date of promulgation thereof.
