

To appropriate an additional amount of money for the requirements of the Department of Cooperative Governance, Human Settlement and Traditional Affairs in respect of the financial year ending 31 March 2011.

BE IT ENACTED by the Northern Cape Provincial Legislature, as follows:-

Appropriation of additional amount of money for the requirements of the Department of Cooperative Governance, Human Settlement and Traditional Affairs.

1. Subject to the provisions of section 25 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), as amended by Public Finance Management Amendment Act, 1999 (Act No. 29 of 1999), there is hereby appropriated out of the Northern Cape Provincial Revenue Fund for the requirements of the Department of Cooperative Governance, Human Settlement and Traditional Affairs an amount of R174 000 000 (One hundred and seventy four million Rand), in respect of the 2010/2011 financial year to provide funding for the creation of sustainable human settlement.

Short title and commencement

2. This Act shall be called the Northern Cape Human Settlements Development Grant Adjustment Appropriation Act, 2011 and shall be deemed to have come into operation on 21 February 2011.
