

- 1 An allowance has been made for the inclusion of discounts for Pensioners meeting certain criteria. The discount is proposed at 50%.
- 2 Public Service infrastructure is no longer feasible to rate due to the regulated rating ratios. It is therefore zero (0) rated.
- 3 Differentiation in the tariffs for the categories "Agricultural Properties" have been included
 - to introduce greater parity within this sector whereby recognition of agriculture, business and residential activities have been made in relation to each other.
- 4 The 2011/2012 financial year saw the implementation of the General Valuation Roll 2011.
- 5 Property rates payers for all categories of property will receive a 10% discount on their rates account if paid in full by the due date of the current account.
