



- 1 An allowance has been made for the inclusion of discounts for Pensioners meeting certain criteria. The discount is proposed at 50%.
- 2 Public Service infrastructure is no longer feasible to rate due to the regulated rating ratios. It is therefore zero (R0) rated.
- 3 Differentiation in the tariffs for the categories "Agricultural Properties" have been included to introduce greater parity within this sector.
- 4 This financial year sees the implementation of the General Valuation Roll 2015.
- 5 There have been additions to the rating categories which have been brought about by recent amendments of the Local Government: Municipal Property Rates Act, 6 of 2004.
- 6 The income threshold for pensioners to qualify for a discount is adjusted to R 130 000 per annum.
