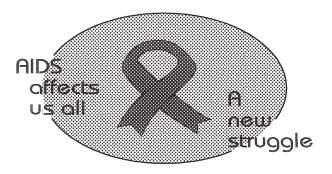

#### EXTRAORDINARY GAZETTES

#### Notice Submission Process

- The Adobe form needs to be completed electronically using Adobe Acrobat / Acrobat Reader. Only

## **C**ANCELLATIONS
