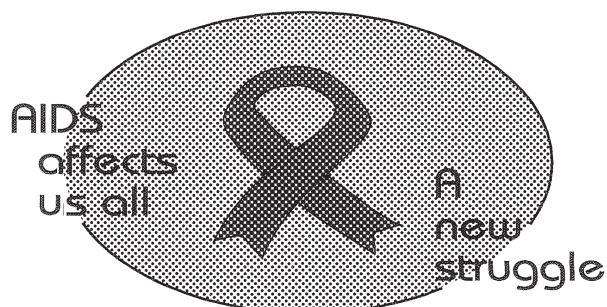

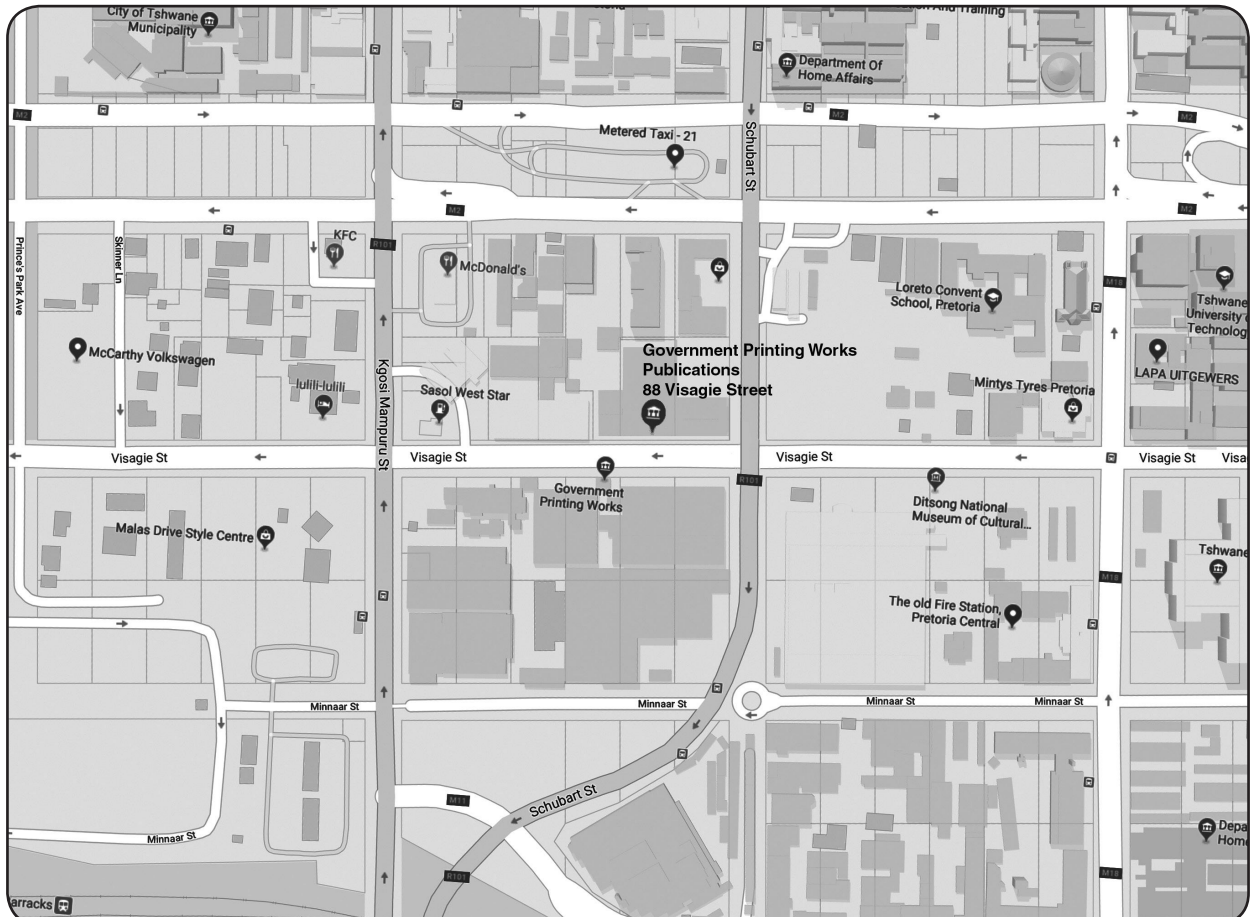

Notice is hereby given, in terms of Item 15 (3) of the Local Government Municipal Planning and Performance Regulation 2001, promulgated under the Local Government: Municipal Systems Act 2000, (Act 32 of 2000) read with the provisions of Section 25(4)(a)(i & ii) of the aforementioned Act, and the provision of the Municipal Finance Management Act 2003, (Act 56 of 2003) of the adoption of the Mohokare Local Municipality's Integrated Development Plan (IDP) 2019/2020 and Budget for 2019/2020 to 2021/2022. The IDP and BUDGET were adopted at an ordinary Council Meeting held on 31 May 2019.

❖ **Rebates**

Government Departments: 0% rebate

Farms and residential: 5% rebate on full settlement of rates levied paid within 3 months from the billing date.

Any person who desires to object to the new tariffs being implemented shall do so in writing, within 14 days from the date of this notice being published in the press, to the Municipal Manager, PO Box 20 Zastron 9950.

All moneys due to the Council will be payable on the first day of the month following the month of consumption and/or usage, failing which, interest may be levied after the due date.
