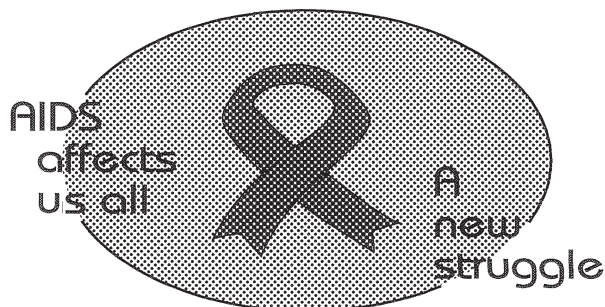

**PREMIER'S NOTICES • PREMIERS KENNISGEWINGS****PREMIERS NOTICE 1 OF 2021*****by the******Premier of the Northern Cape Province*****ESTABLISHMENT OF THE NORTHERN CAPE PROVINCIAL INITIATION COORDINATING COMMITTEE**

1. In terms of Section 11 (1) of the **Customary Initiation Act, 2021 (Act No. 2 of 2021)** (hereafter referred to as the "the Act") read with Section 14 of the **Interpretation Act, 1957 (Act No. 33 of 1957)**, I, **Zamani Saul** hereby,

- a) after consulting with the Members of the Executive Council (MECs) concerned; and
- b) after consulting the Northern Cape Provincial House of Traditional Leaders; and
- c) after taking into consideration the matters listed in paragraphs (a) to (e) of Section 11(1) of the Act,

establish the **Northern Cape Provincial Initiation Coordinating Committee** and determine that the composition of such Committee, shall be as set out in the attached schedule with effect from the commencement date of the Act.

## **Schedule**

### **Composition of the Northern Cape Provincial Initiation Committee**

1. The Northern Cape Provincial Initiation Committee consists of-
  - 1.1 Four (4) members of the provincial house, designated by the members of the provincial house from amongst themselves;
  - 1.2 Two (2) officials from the Northern Cape Provincial Government, designated by the MEC responsible for initiation in the province;
  - 1.3 Two (2) persons representing the district and local municipalities in whose areas of jurisdiction initiation schools are held, designated by the organised local government in the province;
  - 1.4 Two (2) persons representing the emergency services within the province, designated by the MEC or MECs responsible for the respective emergency services within the province; and
  - 1.5 The traditional health practitioner of the Northern Cape Province who, in terms of section 7(c) of the Traditional Health Practitioners Act, is a member of the interim Traditional Health Practitioners Council of South Africa.

### **Designation of members of the Northern Cape Provincial Initiation Committee**

2. A designation made in terms of paragraph (1) must be made in accordance with the provisions of the Act.

### **Meetings and Functions of the Northern Cape Provincial Initiation Committee**

3. The meetings and functions of the Northern Cape Provincial Initiation Committee must be conducted and performed in accordance with the provisions of the Act.
