Calling for filling of vacancies at the John Taolo Gaetsewe Local House of Traditional leaders.

Section 44, read with section 48 of the Northern Cape Traditional Leadership, Governance and Houses of Traditional Leaders Act (Act 2 of 2007) establishes the Local House in the District municipalities where traditional communities exists.


Pursuant thereto, I **Dr Zamani Saul**, in my capacity as Premier of the Northern Cape do hereby call for the filling of vacancies at the Local House in line with the provisions of Sections 44 and 48 of Act 2 of 2007.

There are **four (4)** vacancies existing at the John Taolo Gaetsewe Local House of Traditional leaders. Accordingly, the person designated by myself to chair meetings of the Electoral college and subsequently the first meeting of the Local House, shall preside over the nomination and elections of members by way of a secret ballot.

Therefore, I designate the following person as Chairperson of the Electoral College, to preside over the filling of vacancies and to preside over the first meeting of the Local House. The date, venue and voting times are as follows:

**FILLING OF VACANCIES OF MEMBERS OF THE JOHN TAOLO GAETSEWE LOCAL HOUSE
OF TRADITIONAL LEADERS AND THE DETERMINATION OF THE PROCEDURE TO BE
FOLLOWED DURING THE ELECTION.**

I, **Dr Zamani Saul**, hereby in terms of the Northern Cape Traditional Leadership, Governance and Houses of Traditional Leaders Act (Act 2 of 2007) calls for the filling of vacancies for members of the John Taolo Gaetsewe Local House of Traditional Leaders as set out in the schedule hereunder-

SCHEDULE

Definitions

1. In this schedule, any word or expression defined in the Northern Cape Traditional Leadership, Governance and Houses of Traditional Leaders Act (Act 2 of 2007) (the Act), shall bear such meaning unless the context indicates otherwise.

Existing vacancies

2. (1) The Local House has the following vacancies:
 - (a) Chairperson
 - (b) Deputy Chairperson;
 - (c) Two (2) Headmen/Headwomen
- (2) The members contemplated in sub-paragraph 1 must be elected by the *Electoral College*.

Electoral College

3. (1) The *Electoral College* for the election of members of the Local House shall consist of all the senior traditional leaders from within the John Taolo Gaetsewe District Municipality.
- (2) The Chairperson of the Electoral College must be designated by the Premier in writing.

Nomination of Candidates

4. (1) The Chairperson of the Electoral College must preside over the nomination process.
- (2) (a) The Electoral college nominates candidates for the election as members of the Local House.
- (b) Each member of the Electorate College may nominate two (2) senior traditional Leaders amongst themselves to become a members of the Local House.

- (d) Each member of the Electoral College may nominate two (2) headmen to become members of the Local House.
- (3) When conducting the nominations, the chairperson of the *Electoral College* must comply with the provisions of section 44(5) of the Act.
- (4) Nominations contemplated in subparagraph (2) above, must be in accordance with the following procedure:
 - (a) The Chairperson must call for nominations;
 - (b) A candidate whose name has been proposed must be seconded by at least one member of the Electoral college; and
 - (c) For a nomination to be accepted, a nominee must accept the nomination.
- (5) The nomination and the secondment must be recorded by the Chairperson.

Election Procedure

- 5. (1) The Chairperson must ensure that the required number of ballot papers containing the names of all candidates nominated in terms of paragraph 4 is compiled.
- (2) The Chairperson must ensure that the ballot papers are distributed to all the members of the *Electoral College*.
- (3) Before voting takes place, the chairperson must explain:-
 - (a) the secret ballot voting procedure;
 - (b) that each member of the electoral college may only vote for one of each of the candidates nominated to be elected as members as contemplated in paragraph 2 (b) and (c);
 - (c) that members of the electoral college must deposit their completed ballot papers in the ballot box provided for that purpose.
 - (d) that the counting of votes and finalisation of results will take place once the voting has been finalised; and
 - (e) that the results will be announced immediately after counting has been completed.

Equal number of votes

- 6. In the event that two or more candidates receive an equal number of votes, the result will be determined by lot.
- 7. The Chairperson designated by the Premier should furnish the Premier with a detailed report including the process, nominations, number of votes and the outcome of the votes.

Filling of vacancies

8. Whenever a vacancy arises in the Local House, the candidate with the second highest number of votes will fill the vacancy.

Date, Time and Venue of the Elections:

9. Date of elections is Tuesday, 21 September 2021


Time is 11h00
