

### TERMS OF REFERENCE

**1. PURPOSE**

The Commission shall enquire into, make findings, compile a report with recommendations taking into account the Constitution and the relevant legislation, policies and guidelines as to who is the rightful incumbent to the position of Senior Traditional Leadership of Batlhaping Ba Ga Phuduhutswana Ba Ga Jantjie.

**2. CONDUCT OF THE COMMISSION**

The Commission shall accept any representations whether oral or in writing made by any person who has a claim to the position of senior traditional leadership on behalf of any member of the traditional community.

**3. MEMBERS OF THE COMMISSION**

Adv. S Baloyi (Chairperson)  
Mr Simon Ruthuoane (Senior Anthropologist)  
Mr Zola Maneli (Principal State Law Advisor)

**4. DURATION**

The Commission shall conduct and finalise its work within 6 weeks from date of publication of this.

**5. REMUNERATION OF COMMISSION MEMBERS**

The members the commission who are eligible for compensation shall be remunerated in accordance with National Treasury Guidelines.
