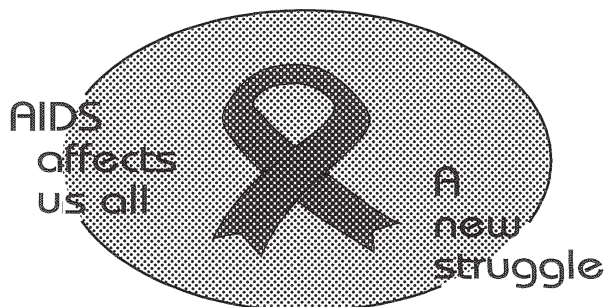

The District Development Model was initiated by President Cyril Ramaphosa in his Budget Speech in 2019. Subsequently, the District Development Model was adopted by Cabinet on 21 August 2019 to express and actualise the intergovernmental relations framework as stipulated in the Constitution of South Africa, 1996. The model also presents a new way of strengthening and synchronising planning by all spheres of government and enhancing the involvement of citizens, business and civil society to support the municipal districts and metros.

The Department of Cooperative Governance (DCoG) has been mandated to manage the DDM across government departments and to ensure a programmatic outcome-based intergovernmental relations and initiatives across all spheres of government in support of the model.

To this end, the MEC of Co-Operative Governance, Human Settlements and Traditional Affairs hereby gives notice that the District Development Model – Draft One Plans of the following districts: John Taolo Gaetsewe, Namakwa, ZF Mgcawu and Pixley Ka Seme have been finalised through a joint and collaborative planning process between various stakeholders.

In line with the democratic government's core objectives of facilitating public participation and involvement in planning processes, we invite stakeholders across all sectors and the public at large to submit comments on the Draft One Plans.
