### RESOLUTION: NC PICC R01-2023-Q3

- a) The PICC accepts the applications submitted by Principals from the Regions/Districts of Frances Baard, Pixley Ka Seme and ZF Mgcawu to open and hold an initiation school.
- b) The PICC approves the applications submitted and further approves that these schools be duly registered in accordance with section 26 (1) (a) of the Customary Initiation Act, Act No. 2 of 2021 and that a formal registration Certificate be issued to each school.
- c) The PICC approves that the list be published in the Provincial Gazette and any local newspaper within the area where the school is to be open and held in accordance with section 26 (3) (a).
