PROCLAMATION

NO . 2

BY THE PREMIER OF THE NORTH-WEST PROVINCE

LOCAL GOVERNMENT TRANSITION ACT, 1993 (ACT NO. 209 OF 1993):
ESTABLISHMENT OF A TRANSITIONAL LOCAL COUNCIL FOR A CERTAIN AREA

1. I, Popo Simon Molefe, Premier of the North-West Province, under Sections 10(1)(a) and 10(3) of the Local Government Transition Act, 1993 (Act 209 of 1993 read with Proclamation No. R129, 1994 published in Government Gazette No. 15894 of 15 July 1994), and with the concurrence of the Provincial Committee for Local Government, hereby establish a Transitional Local Council for the area known as Potchefstroom, and make further and specific enactments as set out in Schedules A, B, C and D to this proclamation.

SCHEDULE A

**FURTHER ENACTMENTS IN TERMS OF THE PROCLAMATION ESTABLISHING THE
TRANSITIONAL LOCAL COUNCIL OF POTCHEFSTROOM IN TERMS OF THE LOCAL
GOVERNMENT TRANSITION ACT, 1993 (ACT 209 OF 1993)**

1. A Transitional Local Council, named the Transitional Local Council of Potchefstroom, is hereby established as envisaged in Section 7(1)(b)(i) of the Local Government Transition Act, 1993 (Act no 209 of 1993), as from the date that this Proclamation becomes effective (hereinafter referred to as the effective date), consisting of the Local Government Bodies of Potchefstroom, Ikageng, Promosa and Mohadin, which Transitional Local Council shall be deemed to be a Local Government Body in accordance with the Local Government Ordinance, 1939, (Ordinance No 17 of 1939).
2. The local government bodies within the Forum area and listed below are disbanded on the effective date:
The City Council of Potchefstroom
The Town Council of Ikageng.
The Management Committee for the area known as Promosa.
The Management Committee for the area known as Mohadin.
3. On the effective date, those persons who at present are serving as councillors of the City Council of Potchefstroom or as members of the Management Committees of Promosa and Mohadin, the names of which are listed in Annexure 1 of Schedule C of this proclamation, and indicated with an asterisk, shall be transferred as a group to the Transitional Local Council as contemplated in paragraph 4 below; provided that the terms of office of the Administrator of the Town Council of Ikageng and the other members of the Management Committees of Promosa and Mohadin, the names of which are not listed in Annexure 1 of Schedule C of this proclamation, shall be terminated on the day preceding the effective date, subject to the provisions of paragraph 5 below in respect of the Town Clerk of the Town Council who, on the day preceding the effective date, may also be the Administrator of the Town Council of Ikageng.
