#### **NOTICE 243 OF 2011**

# THE DECLARATION OF A MORATORIUM ON THE CONSIDERATION OF SPECIAL LIQUOR LICENCES FOR TARVERNS IN THE NORTH WEST

I, Thandi Modise, as the Premier of the Province of the North West, hereby declares a moratorium on the Issuing of special iliquor license for Taverns in accordance with the Functional Areas of Exclusive Legislative Competence under Schedule 5 (Part A) of the Constitution and in terms of the recommendations received from the Member of the Executive Council responsible for the administration and control of liquor licences in the Province, Ms Tebogo Modise, in terms of Section 6A(a) of the Liquor Act No 27 of 1989 (as amended) and assigned to the North West. This moratorium is informed, amongst others, by the following:

- a) The excessive number of Taverns Ilquor licences in existence in the Province,
- The excessive volume of special liquor licences applications received on a monthly basis towards this type of liquor outlets,
- c) The need to clear the current backlog of applications received,
- d) The need to limit the number of operating liquor licences as intended to allow a fair measure of competition and sustainability that will ensure an effective contribution of such businesses into the regional economy,
- e) The need to ensure that all legislative systems required to ensure a conducive ilquor trading environment are in place, (including Municipalities by-laws and regulations towards business sites).

Kindly be informed that this moratorium will be effective for a full calendar year from the date of its publication and that during the period of its existence, no new applications for special licences for Taverns will be considered. Please note that towards the end of the stipulated period, my office will review the situation under advice by the responsible Member of the Executive Council and a new notice will be issued to advice members of the public on any decisions taken.

Your cooperation and understanding in this regard is highly appreciated.
