#### **SCHEDULE**

Notice 304 of 2000 establishing Lekwa-Teemane Local Municipality published in the *North West Extraordinary Provincial Gazette* No. 5574 dated 29 September 2000, as amended, is hereby further amended as follows:

- 1. Amendment of paragraph 3(2) of the Schedule follows:
  - 1(1) by substitution of following words: "The council of the local municipality [shall not]may designate [any]Speaker/Mayor's office in the council to which councillors may be elected, as full-time".
  - 1(2) by repealing paragraph 2 of the Notice 435 of 2003 as published in the North West Extraordinary Provincial Gazette No. 5966 dated 12 December 2003, which revoked designation of full-time office of council
