

### LOCAL AUTHORITY NOTICE 192

#### CITY OF MATLOSANA

**Notice in terms of the provisions of Section 67(3)(a) of the Local Government Ordinance, Ordinance No. 17 of 1939 read with the provisions of Section 21 and Section 21A of the Local Government: Municipal Systems Act, Act No. 32 of 2000.**

Notice is hereby given in terms of the provisions of Section 67(3)(a) of the Local Government Ordinance, Ordinance No. 17 of 1939 read with the provisions of Section 21 and Section 21A of the Local Government: Municipal Systems Act, Act No. 32 of 2000 that it is the intention of the City of Matlosana, a local municipality (hereafter referred to as "the CoM") to close the street indicated between Erf 2185 (in the west) and Erven 2183 and 2184 (in the east) of Extension 38, Klerksdorp, which street is indicated on the approved general plan of Extension 38, Klerksdorp, but is as of yet not constructed, nor has it ever been utilised by the public. The reason for the intended closure being that two alternative accesses have been provided to Extension 38, Klerksdorp, to replace the street which the CoM intends closing and the South African National Roads Agency Limited (hereafter referred to as "SANRAL") has approved the two alternative accesses, which will replace the street that the CoM intends to close, seeing that provision of the two alternative accesses, instead of one access, will result in a better distribution of traffic and a more functional and optimal utilisation of land and municipal services infrastructure.

Note further that a plan depicting the boundaries of the street that the CoM intends to close, as well as its location in Extension 38, Klerksdorp, is open and available for inspection during 9h00 to 13h00 and 14h00 to 15h30 on Mondays to Fridays, to any person who wishes to inspect same, at Room 206, the Civic Centre of the CoM, corner of OR Tambo and Bram Fischer streets, and on the official website of the CoM being [www.klerksdorp.org](http://www.klerksdorp.org).

The local community and/or any person who has an objection or who will have a claim for compensation as a result of such closure of the street is invited to submit written representations and/or objections or claims for compensation in writing to the CoM, same to be submitted to the office of the Municipal Manager of the City of Matlosana by not later than 16 November 2012.

Persons who cannot read or write may visit Room 109, Civic Centre, City of Matlosana, where Mr. D. Ciya will explain the contents of this notice, the proposed road closure, and will assist him/her to transcribe his/her representations and/or objections or claims for compensation.

## PLAASLIKE BESTUURSKENNISGEWING 192

### CITY OF MATLOSANA

**Kennisgewing in terme van die bepalings van Artikel 67(3)(a) van die Local Government Ordinance, Ordinance No. 17 of 1939 saam gelees met die bepalings van Artikel 21 en Artikel 21A van die Local Government: Municipal Systems Act, Act No. 32 of 2000.**

Kennis geskied hiermee in terme van die bepalings van Artikel 67(3)(a) van die Plaaslike Regerings Ordonansie, Ordinansie No. 17 of 1939 saam gelees met die bepalings van die Plaaslike Regering: Munisipale Stelsels Wet, Wet Nr. 32 of 2000, dat die City of Matlosana, 'n plaaslike owerheid (hierin later na verwys as die "CoM"), van voorneme is om die straat geleë tussen erf 2185, ten weste, en erwe 2183 en 2184, ten ooste, van Uitbreiding 38, Klerksdorp, en welke straat aangedui word in die algemene plan van Uitbreiding 38, Klerksdorp, maar welke straat nog nie gebou is nie en derhalwe tot ophede nog nie deur die publiek gebruik is nie, te sluit. Die rede vir die beoogde sluiting van die straat is dat twee alternatiewe toegangs strate voorsien word na Uitbreiding 38, Klerksdorp, om die straat te vervang wat die CoM van voorneme is om te sluit en dat die Suid-Afrikaanse Paaie Agentskap Beperk (hierin later na verwys as "SANRAL") die twee alternatiewe toegangs strate goedgekeur het wat op hulle beurt die straat wat die CoM voornemens is om te sluit sal vervang aangesien die verskaffing van twee alternatiewe straat toegange in plaas van eenstraat toegang, 'n beter vloei van verkeer te weeg sal bring en 'n meer funksionele asook optimal gebruik van grond en munisipale dienste infrastruktuur sal hê.

Neem verder kennis dat 'n plan wat die grense van die straat wat beoog gesluit te word, sowel as die ligging daarvan in Uitbreiding 38, Klerksdorp, beskikbaar is en ter insae sal lê vanaf 09h00 tot 13h00 en vanaf 14h00 tot 15h30 Maandae tot Vrydae vir enige persoon wie dit wil besigtig, te Kamer 206, die Burgersentrum van die CoM, hoek van OR Thambo en Bram Fischerstrate, en ook op die amptelike webblad van die CoM te wete [www.klerksdorp.org](http://www.klerksdorp.org).

Die plaaslike gemeenskap en/of enige persoon wie beswaar wil aanteken of wie 'n eis mag hê vir vergoeding as gevolg van sodanige straatsluiting, word hiermee uitgenooi om skriftelike vertoë te rig en/of besware of eise vir genoeg doening in te dien by die CoM, welke ingedien moet word by die kantoor van die Municipale Bestuurder van die CoM teen nie later dan 16 November 2012.
