

NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT, 2001

APPLICATION FOR REMOVAL OF BUSINESS TO OTHER PREMISES IN TERMS OF SECTION 45 OF THE NORTH WEST GAMBLING ACT 2001, (Act No.2 OF 2001), AS AMENDED.

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act"), that the North West Gambling Board ("the Board") received an application from Basfour 3739 (Pty) Ltd, trading as, Galaxy Bingo North West (Pty) Ltd, for the removal of gambling business from the current approved licensed premises to other premises.

Galaxy Bingo North West (Pty) Ltd lodged the application in terms of the provisions of section 45 of the Act to remove the Bingo business from the licensed premises at Village mall, Corner Rustenburg Road and Magalies Boulevard, Schoemanville in Hartebeespoort, to the new premises situated at shop No 39 Brits Mall, Corner Hendrik Verwoerd and Maple Ridge Road in Brits.

Please take note that this application will lie for public inspection at the offices of the Board, ABSA Building at 131 University Drive, Mmabatho, between 08h30 – 16h30, for a period of one (1) month, commencing from 07 October 2013 to 06 November 2013.
