

NOTICE IN TERMS OF SECTION 23 OF THE LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998

THE NOTICE PUBLISHED ON 10 DECEMBER 2013 IN THE NORTH WEST PROVINCIAL GAZETTE, GAZETTE NO. 7201 (EXTRAORDINARY) IS HEREBY CORRECTED BY SUBSTITUTING THE HEADING "NOTICE IN TERMS OF SECTION 23 OF THE LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998 READ WITH THE CONSTITUTION TWELTH AMENDMENT ACT, 2005 AND THE CROSS-BOUNDARY MUNICIPALITIES LAWS REPEAL ACT, 2005", WITH THE FOLLOWING HEADING: "NOTICE IN TERMS OF SECTION 23 OF THE LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT 1998";

And by substituting the first paragraph "In terms of section 23(2) of the Local Government: Municipal Demarcation Act, 1998, read with the Constitution Twelfth Amendment Act, 2005 and the Cross-Boundary Municipalities Laws Repeal Act, 2005, the Electoral Commission hereby expresses the view that the boundary re-determinations as determined by the Municipal Demarcation Board in terms of section 21(5)(c) of the Local Government: Municipal Demarcation Act of the municipalities referred to in the Schedule will not materially affect the representation of voters in the councils of the municipalities", with the following paragraph "In terms of section 23(2) of the Local Government: Municipal Demarcation Act, 1998, the Electoral Commission hereby expresses the view that the boundary re-determinations as determined by the Municipal Demarcation Board in terms of section 21(5)(c) of the Local Government: Municipal Demarcation Act of the municipalities referred to in the Schedule will not materially affect the representation of voters in the councils of the municipalities."
