

RUSTENBURG LOCAL MUNICIPALITY PUBLIC NOTICE CALLING FOR INSPECTION OF THE VALUATION ROLL AND LODGING OF OBJECTIONS

Notice is hereby given in terms of section 49(1) (a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that the Valuation Roll for the financial years 1 July 2014 to 30 June 2018 is open for public inspection at Rustenburg Local Municipality from 21 February 2014 to 31 March 2014. In addition the Valuation Roll is available on our website www.rustenburg.gov.za and at the following venues:
