



RUSTENBURG LOCAL MUNICIPALITY PUBLIC NOTICE CALLING FOR INSPECTION OF THE SUPPLEMENTARY VALUATION ROLL (2013/2014) AND LODGING OF OBJECTIONS

Notice is hereby given in terms of section 49(1) (a) (i) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that the Supplementary Valuation Roll for the financial years 1 May 2013 to 31 March 2014 is open for public inspection at Rustenburg Local Municipality from 21 April 2014 to 31 May 2014. In addition the Supplementary Valuation Roll is available on our website www.rustenburg.gov.za and at the following venues:

- 1. Municipal libraries situated at Boitekong; Karlienpark; Marikana and Rustenburg
- 2. Municipal Regional Community Center's (RCC) situated at Boitekong; Lethabong; Monnakato; Marikana; Phatsima and Tlhabane.

An invitation is hereby made in terms of section 49(1) (a)(i) of the Act that any owner of property or other person who so desires should lodge an objection with Acting Municipal Manager in respect of any matter reflected in, or omitted from, the general valuation roll within the abovementioned period.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the general valuation roll as such.
