Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act"), that the North West Gambling Board ("the Board") received an application from I Slots (Pty) Ltd- Klerksdorp for the removal of gambling business from the current approved licensed premises to other premises.
