The core function of the Tribunal is the resolution of disputes between tenants and landlords arising out of unfair practices.

QUALIFICATIONS FOR MEMBERS OF THE NORTH WEST RENTAL HOUSING TRIBUNAL:

- Each person shall be nominated separately
- Each person shall have knowledge and expertise:
 - In property management or housing development matters
 - In consumer matters pertaining to rental housing development matters;
 - In legal matters with practical court experience and/or
 - In conflict resolution or mediation skills

NOMINATION PROCESS:

Nomination should be submitted in writing and must contain the following:

- Nomination letter and Acceptance of Nomination
- CV/Profile of nominee
- Certified copy of Identity document of nominee
- Declaration of conflict of interest
- Disclosure of business interest

NOMINATIONS SUBMISSIONS:

Nominations should be submitted by no later than **28 February 2020 at 16h30**; in a closed envelope marked "Nominations to serve in the North West Rental Housing Tribunal".
